

**CONSENT AND RELEASE**

*Your teenage child named below (the "Participant") has pre-registered for The Shoppes at Blackstone Valley's First Annual Teen Correspondent contest (the "Contest"), which is to be held on May 14, 2011 at the Shoppes at Blackstone Valley. W/S Development Associates LLC and S.R. Weiner & Associates, Inc. (together, the "Sponsor") must have your consent and release as a parent or legal guardian of the Participant before he or she will be permitted to participate in the Contest.*

1. I am the parent or legal guardian of the Participant and am at least 21 years of age.
2. I consent to the Participant's participation in the Contest.
3. I agree that the Participant may be photographed, filmed, taped, or otherwise recorded (each a "Recording") by the Sponsor or its contractors, either individually or as part of a group Recording, which may include the Participant's image, likeness, and/or voice. I further agree that the Participant's name may be used to identify him/her as a subject of any Recordings featuring his/her image, likeness, and/or voice.
4. I understand that the Sponsor will own all rights in the Recordings of the Participant, and that the Sponsor will have the exclusive right to use, or allow others to use, such Recordings for any purpose in all forms and media throughout the world. Without limiting the generality of the foregoing, the Sponsor and its licensees may reproduce, display, distribute, edit, and create derivative works and compilations of the Recordings for purposes of allowing others to judge and vote in the Contest and for other purposes relating to the Contest.
5. On behalf of the Participant, I waive any and all rights of privacy and/or publicity that would otherwise preclude the Sponsor or its licensees from using the Recordings of the Participant.
6. I acknowledge that the Sponsor has no obligation to use any Recordings of the Participant or to use such Recordings for any particular purpose.
7. I understand that neither I nor the Participant will receive any monetary payment or other consideration in exchange for the rights to use the Recordings of the Participant or for the Participant's participation in the Contest.
8. On behalf of the Participant, I hereby release and forever discharge the Sponsor, its affiliates, and each of their respective directors, officers, employees, volunteers, and agents from any and all liabilities, claims, demands, damages, rights, and causes of action of whatever kind, nature, or description, present or future, asserted by the Participant or on behalf of the Participant by any other person, including by me or any of the Participant's heirs, executors, or assigns, that arise out of or relate in any way to the Participant's participation in the Contest or the use of any Recordings of the Participant.
9. I agree that this Consent and Release may not be altered orally. I have read and fully understand the meaning and effect of this Consent and Release, and I intend to be legally bound by it.
